

**INSTRUCTIONS TO PERSON GIVING DECLARATION REGARDING  
CLAIMANT AS “RENTER”**

The declaration on the next page may be used to document that the Claimant “rented” at a residence that he or she did not own. The person signing the declaration must be truthful, as he/she must sign “under penalty of perjury.”

It must be completed by a person who is over 18 years of age, and who did not live with the Claimant at the residence but was familiar with the Claimant’s living situation.

**Paragraph 1** – Print your full name in the first blank. Print the full name of the Claimant in the second blank. In the third blank write the address where the Claimant lived.

**Paragraph 2** – Use the space provided to describe in detail what you know about the Claimant’s having provided money or other value (including services, home furnishings or other things of value) to the household *in exchange for the right to live at the owner/renter’s property* over the time-period indicated. For example, you might know that, in exchange for the right to live at the *property*, the Claimant:

- paid rent or a portion of the rent on a regular basis;
- provided groceries on a regular basis;
- provided home furnishings used by the owner/renter or his/her household;
- cleaned the house on a regular basis;
- maintained the home on a regular basis; or
- provided care to the owner/renter or a household member on a regular basis.

**Paragraph 3** – Use the space provided to explain how you know that the Claimant provided these things (money or other things of value or services) to the owner/renter in exchange for the right to live at the property. For example, you personally knew the claimant and owner/renter and frequently visited at the residence.

**Bottom of Page** – Write the date, your signature, address, phone number, and (if you have one) email address.

Continue to the next page to complete the declaration.
